

APPEL DU COMITE POUR LE RESPECT DES DROITS DE L'HOMME ET LA DEMOCRATIE AU RWANDA

L'envoi d'armes et de parachutistes belges au Rwanda s'avère aujourd'hui avoir été un soutien direct à un régime non respectueux des droits de l'Homme.

La présence des troupes belges a permis de dégager les forces de l'armée rwandaise et de l'armée zaïroise, pour mener plus efficacement la répression avec des méthodes inacceptables, exécutions sommaires...

Le régime du président Habyarimana au pouvoir depuis 17 ans est une dictature fondée sur un parti unique à la solde d'un président inamovible.

Ce régime a favorisé la corruption à tous les échelons du pouvoir. Il a institutionnalisé la discrimination raciale en spécifiant l'appartenance ethnique HUTU, TUTSI, TWA sur la carte d'identité, ainsi qu'une discrimination régionale en favorisant la région natale du président au détriment du reste du pays.

La décision du gouvernement de retirer les parachutistes ne met pas fin au soutien militaire belge à ce régime. Le soutien se poursuit sous d'autres formes : logistique et financière...

Pour ces raisons, le comité lance un appel urgent :

- pour l'arrêt de chaque appui politique et militaire au régime du président Habyarimana
- pour une alternative démocratique au Rwanda

- 1.* Mrs Béatrice Mukarumongi, Kigali: a woman with an unspecified number of children, employee at CORWACO (Kigali: a firm belonging to Mr Kajeguhakwa (an important businessman who fled from Rwanda recently, after having been harassed during many weeks for political reasons: see Amnesty International documents), belongs to Batutsi group
 - 2.* Mrs Aziza Murebwayire, Kigali, approx. 20 years old, a secretary at Rwigara Cigarettes Company, Kigali, (see nr 98), arrested on wednesday, Oct., 3, belongs to Batutsi group
 - 3.* Mr Anselme Rusingiza, Kigali: approx. 22 years old, an employee at Rwigara Cigarettes Company, Kigali (see nr 98), arrested on wednesday, Oct., 3, belongs to Batutsi group
 - 4.* Mr Evariste Sisi, Kigali: an important businessman, presumably killed by the army, belongs to Batutsi group
 - 5.* Mr Gérard Ntashamaje, Kigali: approx. 30 years, minister's son, jurist at Bralirwa breweries, belongs to Batutsi group

- 16.* Mr Landoald Ndasingwa, Kigali: 44 years, a physical handicapped, former professor of Literature at Rwanda National University (U.N.R.), hotel owner, married with Mrs Hélène Pinsky, a canadian, has been ill-treated during his present detention, still detained despite an intervention in his favour by canadian personalities among whom Rev. Father Georges Lévesque, founder of the Rwanda National University, belongs to Batutsi group
- 17.* Mr Jean Mbaguta, Kigali: approx. 47 years, managing director (directeur général) of the state-controlled Bureau National d'Etudes de Projets (Kigali), belongs to Batutsi group
- 18.* Mr Etienne Gakwaya, Kigali: approx. 37 years, businessman, belongs presumably to Bahutu group
- 19.* Mr François Munyampundu, Kigali: approx. 50 years, a businessman, ethnic group unspecified
- 20.* Mr François-Xavier Kayiranga, Kigali: approx. 40 years, married with Mrs Thérèse Mukamitali (see nr 36), an employee at a petrol station belonging to Mr Valence Kajeguhakwa (see nr 1), belongs to Batutsi group
- 21.* Mr Fidèle Mutaganda, Kigali: approx. 52 years, a businessman, belongs to Batutsi group
- 22.* Father Epimaque Sherti, Kamonyi: age unknown, a priest at Kamonyi Parish (Central Rwanda, near Kabgayi), belongs to Batutsi group (information published by La Libre Belgique, oct. 5th, 1990 under Marie-France Cros's signature, no other source available)
- 23.* Mrs Cécile Mutabonwa, known as Nyirabihogo, Butare: approx. 40 years, a businesswoman, belongs to Batutsi group
- 24.* Mr Serge Rwamasirabo, Kigali: approx. 38 years, M. Sc., Agricultural Economy, a senior civil servant at Ministère de l'Agriculture, de l'Elevage et des Forêts, belongs to Batutsi group
- 25.* Jacqueline Cyamazima, Kigali: Beatrice Mukarumongi's sister (see nr 1), age unknown, profession unspecif., a Prof. Alexandre Kimenyi (Univ. of Sacramento, editor of rwandese journal Impuruza) 's wife's aunt, belongs to Batutsi group
- 26.* Mr Anselme Sakumi, Kigali: age unknown, a businessman, belongs to Batutsi group

- 29.* Major Sebakunzi, Kigali: age unknown, personal situation unspecif., senior officer in the Forces Armées Rwandaises (National Army); his arrest was confirmed on the 13.10.90 by Mr Alphonse Marie Nkubito, a senior magistrate who was appointed President of the Commission dealing with these political detainees (see Kinyamateka, nr 1331, p.10), belongs to Bahutu group
- 30.* Commander Kayinamura, Kigali: age unknown, personal situation unspecif., belongs to Bahutu group

32. Mrs Anne-Marie Habimana-Kantengwa, Kigali: approx., 40 years, Mr Landoald Ndasingwa's sister (see nr 16), married to Mr Joseph Habimana (see nr 31), 4 children, presumably released recently, belongs to Batutsi group
- 33.* Mr Aloys Twizere, Kigali (BP 865): age unknown, book-keeper at ERP (a firm belonging to Mr Valence Kajeguhakwa, see nr 1), presumably killed during questioning in Ruhengeri Maximum Security Prison, belongs to Batutsi group
34. Mrs Florence Kayiranga, Kigali: approx. 40 years, a widow (of Mr Epaphrodite Ngirumpatse) with 3 children, an employee at PNUD (United Nations Development Program) Kigali Office, released, due to her employer's intervention, after more than 3 weeks of detention, belongs to Batutsi group
- 35.* Mrs Agnès Mukanyampeta, Kigali: age unspecified, 3 children, a nurse at PNUD Kigali Office, belongs to Batutsi group
- 36.* Mrs Thérèse Mukamitali, Kigali: age unspecified, Mr François-Xavier Kayiranga's wife (see nr 20), arrested at the very beginning of the repression (tuesday, oct. 2nd?), belongs to Batutsi group with family links in Uganda
- 37.* Major Mutambuka, Byumba: age unknown, officer in the Forces Armées Rwandaises (National Army), commanding the Byumba military area; his arrest was confirmed on the 13.10.90 by Mr Alphonse Marie Nkubito, a senior magistrate who was appointed President of the Commission dealing with these political detainees (see Kinyamateka, nr 1331, p.10), belongs to Bahutu group
- 38.* Mrs Jeanne Umurerwa Condo, Kigali: age unknown, secretary to the Director of the ELECTROGAZ, Mr Pasteur Bizimungu (who fled in Uganda, and is now the Rwandese Patriotic Front [R.P.F.] spokesman), still in prison despite numerous interventions, belongs to Batutsi group.
NB. Her sister Gertrude Condo (Condo is her patronym, she may have another personal name), approx. 40 years, married to Mr Léon Chopack, a belgian citizen, has been detained as well for 4 days, and gravely tortured; her liberation is due to external pressure from many belgian and international instances; she reached Belgium on wednesday, oct. 10th, and has testified about the abominable conditions of detention of the thousands of political detainees in Kigali (see RTL, BRT Broadcastings, & newspapers).

- 42.* Miss Marie-Paule Sebera, Cyangugu: approx. 26 years, studied tourism at Institut Charles Péguy, Louvain-La-Neuve (Belgium), was working with a american wildlife protection team in Kamembe (Cyangugu prefecture) & living in Cyangugu town at the time of her arrest, arrested with two brothers (see 43 & 44), belongs to Batutsi group

- 45.* Mr Daniel Kabaka, Kigali (Mumena area, an area known as being inhabited by an important number of Batutsi widows whose husbands have been killed by the army in 1963): approx. 45, married to Mrs Dafroza Mukandagara Semugeshe (see nrs 89, 90, 91, 92, 93); his elder brother, Mr Ndahiro, was arrested and killed by the army in 1963, in similar circumstances; employee (firm unknown), has been gravely ill-treated, belongs to Batutsi group
- 46.* Mr Antoine Mazimpaka, Kigali, 44 years, an employee (firm unknown), Mr Denis Burabyo's son (Denis Burabyo was one of the leaders of the "National Union of Rwanda" [UNAR], one of the major political parties founded in 1959; Mr Burabyo was killed by the rwandan army in 1963 following an attack by armed insurgents from neighbouring countries), belongs to Batutsi group
- 47.* Mr Jean-Paul Muvunyi, Kigali: approx. 30 years, a private pilot, presumably killed by the army, belongs to Bahutu group
- 48.* Mr Eugène Murenzi, Nyanza: age unknown, a civil servant in the customs services, arrested with his wife, ethnic group unspecif.
- 49.* Mr Faustin Harerimana, Kigali: age & personal situation unknown, belongs to Bahutu group
- 50.* Mr Innocent Rubagumya, Kigali: approx. 35 years, a journalist at the private sports newspaper *Stades*, may have been gravely ill-treated belongs to Batutsi group
- 51.* Mr Védaste Rubangura, Kigali: approx. 55 years, a businessman (transport & manufacturing), married, approx. 8 children, presumably killed by the army (information as yet unconfirmed), belongs to Batutsi group
52. Father André Sibomana, Kabgayi: aged between 30 & 40 years, one of the 30 "manifesto for multipartism" signers, director of the Catholic Church owned newspaper *Kinyamateka*, recently incriminated, after publication of critical articles in his newspaper, then cleared, presently free (information about his arrest during the first days of the present crisis as yet unconfirmed, may have been "simply" questioned), belongs to Bahutu group
- 53.* Mr Egide Musafiri, Kigali (?): no other information available now
- 54.* Mr Martin Rutungura, Kigali (?): age & personal situation unknown, presumably killed by the army, ethnic group unspecif.
- 55.* Mr Protais Iyakaremye, Kigali (?): no other information available now
56. Mr Ephrem Mbuguliye, Kigali: aged between 30 & 40 years, manager of the development N.G.O. ADRI-DUHAMIC, married, released after having been detained during a certain number of days, belongs presumably to Bahutu group

- 63.* Mr Jason Muhayimana, Kigali: approx. 34 years, head of department at Rwigara Cigarettes Company (see nr 121), belongs to Batutsi group
- 64.* Mr Ignace Gasinzigwa, Kigali: approx. 36 years, married, 2 children, head of department at Rwigara Cigarettes Company (see nr 121), belongs to Batutsi group

- 73.* Mr Faustin Semuhungu, Kigali: approx. 44 years, senior executive (fondé de pouvoir) at Banque de Kigali (at Kigali), belongs to Batutsi group

74.* Mrs Donatila Gaparayi Kagorora, Kigali (Kiyovu area): approx. 40 years, approx. 4 children (Mr Albert Kagorora's sister, see nr 70; she appears in the picture published by the Belgian newspaper *Le Soir* on 15.10.90), belongs to Batutsi group

75.* Mr Canisius Kamali, Kigali: approx. 44 years, businessman, (a H.E. Mr Ambassador Katabarwa's younger brother; Mr Katabarwa is the Rwanda Ambassador in Rome), may have been released recently following unconfirmed information, belongs to Batutsi group

76.* Ms Assumpta, Kigali: approx. 25 years, a civil servant at the state-controlled Radio Rwanda (Rwanda Broadcastings Services), belongs to Batutsi group

77.* Mr Claude Kalisa, Cyangugu: approx. 22 years, a laboratory assistant at CIMERWA (Cyangugu), belongs to Batutsi group

78.* Mr Senuma, Cyimbogo (Cyangugu Prefecture): approx. 50 years, a driver at Mibirizi Hospital, belongs to Batutsi group

79.* Mr Evariste Ntagara, Cyangugu: approx. 35 years, a businessman, belongs to Batutsi group

80.* Mr Karangwa, Winteko (Cyimbogo Municipality, Cyangugu Prefecture): approx. 28 years, a businessman, belongs to Batutsi group

81.* Dr Rudakubana, Ruhengeri: approx. 30 years, a surgeon at Ruhengeri Hospital (a brother-in-law of Antoine Mugesera, one of the "manifesto for multipartism" signers), belongs to Batutsi group

82.* Mrs Adela Rwigemera-Kantengwa, Kigali: aged between 50 & 55 years (her husband, Mr Gérard Rwigemera, and a certain number of children live out of Rwanda, respectively in Kenya and Belgium), arrested at the same time as her son "Kiki" (see nr 83), suffers of diabetes, presumably dead in detention through lack of medical assistance (information as yet unconfirmed), belongs to Batutsi group

83.* Mr Rwigemera "Kiki", Kigali: approx. 20 years, personal situation unspecified, arrested at the same time as his mother, Mrs Adela Rwigemera-Kantengwa (see nr 82), belongs to Batutsi group

84.* Mrs Régine Muvara, Kigali: aged between 25 & 30 years, married to Mr Muvara, a rwandese footballer presently living & working (?) in Belgium, 2 children (her picture appeared in the Belgian newspaper *La Libre Belgique* on 15.10.90), belongs to Batutsi group (while her husband belongs to Bahutu group)

85. Mr Ephrem Setako, Gisenyi: 70 years (Mr Aloys Twizere's father, see nr 33) a Hatton & Cockson pensioner, has been previously detained & ill-treated in 1963, in similar circumstances; this time he has been arrested, detained, then released, and then rearrested; presently free following recent information, belongs to Batutsi group

86.* Mr Joseph Bayingana Nzirabatinyi jr, Kigali: approx. 35 years, businessman, belongs to Batutsi group

87. Mr Jean Birara, Kigali: approx. 55 years, former governor of the National Bank of Rwanda, detained presumably during 3 days, belongs to Bahutu group

- 88.* Mr Vincent Bizimungu, Kigali, approx. 35 years, civil engineer, belongs presumably to Bahutu group
- 89.* Mrs Dafroza Mukandagara Semugeshi, Kigali (Mumena area): approx. 53 years; her 1st husband, Mr Ndahiro, was arrested & killed by the rwandan army in 1963; her 2nd husband, Mr Daniel Kabaka (see nr 45), her son-in-law, Mr Célestin Musabyimana, and 3 children have been arrested & are detained as well, under the present move of repression, may have released recently, belongs to Batutsi group
- 90.* Mr Célestin Musabyimana, Kigali: approx. 30 years, Mrs Dafroza Mukandagara Semugeshi's son-in-law (see nr 89), married with Mrs Angélique Ndahiro (see nr 91), a member of the management of the state-owned ELECTROGAZ (about ELECTROGAZ, see nr 38, NB), belongs to Batutsi group
- 91.* Mrs Angélique Ndahiro, Kigali: approx. 27 years, Mrs Dafroza Mukandagara Semugeshi's daughter (see nr 89), married with Mr Célestin Musabyimana (see nr 90), a bank employee, belongs to Batutsi group

124. Mr Munyambonwa, Gisenyi: aged between 50 and 60 years, personal situation unknown, presumably killed by the Army, with his wife and children, ethnic group unspecif.

125. Mr Apollinaire Bukuba, Nyagatare: 75 years, killed with other villagers in Nyagatare area, belongs to Batutsi group
